1. That he will not be entitled fix medical allowance w.e.f. **18.12.2013** and the fix medical allowance, if any, paid to him after the date of change of option will have to be deposited in Government Treasury.
2. That he will not be entitled fix medical allowance until he avails open medical allowance facility.
3. That the option has been changed as the employee's wife is suffering from chronic disease. The certificate in this regard has been issued by Civil Surgeon, Narnaul vide **No. 254 dated 18.12.2013**.
4. The Medical Certificate is to be reviewed/renewed after a period of two years or before date of its expiry whichever is earlier otherwise his/her medical option will be changed from open to fix automatically.
5. The reimbursement will be made only for chronic diseases declared by Haryana Govt. from time to time.
